



**Thank you so much for consigning in itty bitty boutique's Spring/Summer 2010 Kids' Consignment Sale! Please review the following, and initial that you have read and agree to all of the statements listed:**

\_\_\_ I acknowledge that I am submitting children's clothing and goods for sale in **itty bitty boutique's** Kids' Consignment Sale. I understand that all sales are final, and no record of purchases is being kept in order to track down items sold at a later time.

\_\_\_ I certify that I am not knowingly entering any item(s) in the sale that have been recalled for any reason, nor have I attempted to disguise the fact that an item is broken or is missing pieces.

\_\_\_ I agree that I will accept 70% of the total sales of my items sold, while **itty bitty boutique, LLC** will earn a 30% commission. If I am a Volunteer Worker that **completes** two or more four-hour shifts during the sale, I understand that I will receive 75% of my total sales, while **itty bitty boutique, LLC** will keep 25%.

\_\_\_ I understand that a \$12 administration fee will be deducted from my proceeds check to help offset the cost of facility rental, advertising, and sale supplies.

\_\_\_ I am aware that sale organizers have the right to deem any item brought to drop-off as inappropriate for the sale, whether due to condition, tagging, or any other reason, and that those items will be given back to me at that time. I further understand that items may be removed from the sales floor after drop-off if they are later determined to be inappropriate for the sale. Those items will be set aside and returned to me at Consignor Pick-Up.

\_\_\_ If it is later discovered that I neglected to price an item, I give **itty bitty boutique, LLC** sale organizers permission to price the item for me so that it may remain on the sales floor.

\_\_\_ I am aware that Saturday is Half Price Day, and all remaining items will be sold at 50% of my tagged price, unless I indicate ND (No Discount) in red on the bottom left corner of the tag on those items I do not want discounted.

\_\_\_ I agree that **itty bitty boutique, LLC** and its sale organizers will not be held responsible for items that are lost, damaged, or stolen during the course of the sale, though every effort will be made to prevent these circumstances.

**\_\_\_ I agree to collect all of my unsold items on Saturday, March 13<sup>th</sup> between 7:00 pm and 8:30 pm, or designate someone to do so for me. I understand that if my items are not picked up during this hour, they will be donated to a charity of the sale organizers' choice. If an unexpected issue arises at a later date that prevents me from collecting my goods, I acknowledge that I will accept the responsibility of finding someone to claim my unsold items for me, or I will allow them to be donated to the aforementioned charity. I understand that there are NO EXCEPTIONS to this policy, and I will not ask that an exception be made for me.**

\_\_\_ I understand that my check will be mailed to me on or before March 31, 2010. My Consignor tags will not be mailed to me, but they will be made available to me if I choose to contact sale organizers and arrange to pick them up at a specified time/place.
